Present: Ellen Koplin, Chair; Lowell Linde, Vice-Chair; Timothy Cougle, Supervisor; Mark Cappuccio, Township Solicitor; Emily Fucci, Township Administrator/Secretary; and 26 members of the Public.

The meeting was called to order at 6:36PM by Koplin.

All stood for the Pledge of Allegiance.

Number 19 "Summary of Meeting with PennDOT to discuss resident petitions from Hosensack and Limeport" was moved forward to accommodate the members of the public present for the matter. Fucci provided the Board with an overview of the meeting held on March 20, 2024 with PennDOT regarding the resident petitions. Fucci provided information on how to proceed if the Board wanted to install speed display signs on Kings Highway or Limeport Pike. Public comments were received from residents Ed Lounsberry, Bonnie Smith, Bill Smith, Donald Cooper, Ed Gangawere, Kelly Houser, Lori Sickenberger, Ron Tomes and Jason Flexer regarding traffic concerns on Kings Highway and Limeport Pike and finding a solution with PennDOT to address the concerns.

Motion by Linde to approve the March 21, 2024 regular meeting minutes as presented. Seconded by Cougle and unanimously approved.

Motion by Linde to approve the April 4, 2024 workshop meeting minutes as presented. Seconded by Cougle and unanimously approved.

Koplin announced the Administrator Report for April 18, 2024, the Zoning report for March 2024, the Public Works report for March 2024 and the Administrative Assistant report for March 2024. Motion by Linde to accept the reports as presented. Seconded by Cougle and unanimously approved.

Koplin announced the March 2024 Macungie Ambulance report.

Fire Company representative Ed Miller thanked the Township for opening Limeport Pike after a recent storm when both PennDOT and Verizon refused to move a fallentree. Miller announced the Spring Craft Show is being held on Saturday, April 20, 2024, hoagie sales and perogie sales are currently accepting orders and they are planning to potentially hold bingo. Miller has not received any updates on the upcoming County upgrade of radio systems.

Under Old Business:

Fucci confirmed there has not been an update on vacating Janes Lane and the item was tabled.

Discussion was held on the bids received for the office roof replacement. Motion by Cougle to tabled awarding the bid for the office roof replacement until the May 16, 2024 regular meeting to allow for additional time to review all bids received. Seconded by Linde and unanimously approved.

Koplin announced receipt of Docket No. 24-04, appeal of Shane McGann for a special exception for a home related business at 4045 Limeport Pike Coopersburg, PA 18036. Motion by Cougle for the Township Solicitor to write a letter to the Zoning Hearing Board to voice their concerns on the location of the outdoor storage and any effects the business could have on the floodplain. Seconded by Linde and unanimously approved.

Motion by Cougle to initiate the seven-year review of the Agricultural Security Area. Seconded by Linde and unanimously approved.

Motion by Linde to authorize the Lower Milford Township Fire Police to assist Milford Township with the Volunteer Fire Company Annual Carnival from June 18, 2024 to June 22, 2024 and the Milford Township Annual Ag-Daze on September 14, 2024, Seconded by Cougle and unanimously approved.

Under Correspondence:

Koplin announced the April 2024 social security newsletter.

Koplin announced the County of Lehigh Board of Assessment Appeals "Board Decision Notice" for the Breach of Act 319 for John W. and Lisa L. Spurlock.

Koplin announced Lehigh County Conservation District's free household hazardous waste event on Saturday, April 27, 2024 from 10:00AM to 12:00PM.

Under Public Comment:

Arland Schantz asked if PennDOT had a time frame for the grate bridge replacement on Limeport Pike and expressed his concerns on the bridge closure. Schantz also asked if the Township had received notice regarding First Energy's upgrade of the high tension lines through this property.

Adrian Wooden asked what type of development could be put at the location of Dan Schantz Greenhouse now that they are out of business. Koplin responded that the property is a preserved farm and can only be used for agricultural purposes.

Jason Flexer asked if the Township has begun looking at regulations for solar farms.

Motion by Linde to adjourn the meeting. Seconded by Cougle and unanimously approved.
